In consideration of being given a place in the Louisville Youth Orchestra (the "LYO"), being permitted to perform with the LYO, receiving the training and experience associated with membership in the LYO, and the other musical, social and educational benefits associated with membership, the Player or the parent/legal guardian of the Player agrees as follows:

Any products of the Player's performing with the LYO belong to the LYO and not to the Player. Those products might include, among other things, recordings of LYO performances on tape, disc, record, .mp4 or .mov, or other media, moving or still pictures, musical scores, and other like and unlike products.

The LYO is authorized to make still, single, multiple and/or moving photographs of the Player, alone or in conjunction with other LYO members. The LYO may copyright and will be the sole owner of said photographs. The LYO may publish those photographs and use them in all forms, media and manners for advertising, trade, promotion, exhibition or any other lawful purposes. The LYO may cause said photographs to be composite, distorted or altered for artistic, cosmetic or commercial purposes. The LYO may (but is not required to) use the Player's name in conjunction with the photographs. Neither the Player nor anyone on behalf of the Player will have any right to inspect/approve the finished product, or any advertising or copy that might be used in connection with the finished product, or the use to which it will be employed.

In addition, the player and parents of the player agree to allow his/her email(s) and telephone number(s) to be utilized in conjunction with a contracted notification service dedicated to the use of contacting said player with information specifically pertaining to the organization. The LYO agrees that any email or phone number utilized in this manner will not be sold or directed to any other individual, company, or business.

The Player, his/her legal representatives, heirs, executors, successors and assigns release the LYO, its officers, directors, employees, attorneys and agents from any liability arising out of their use of any photographs or products which the LYO is authorized to make and/or use under the terms of this Consent and Release.

If this consent and Release is signed by a person other than the Player, that other person represents that he/she is the Player's natural parent or other legal guardian, and as such has full power and authority to sign this Consent and Release on behalf of, and to bind, the Player, and his/her heirs, executors, successors and assigns.
